

DURA-SHIELD™ HARDCOVER Limited Warranty

DuraShield HardCover: Lifetime Prorated Warranty

StrongTM Spas warrants the integrity of the factory installed DuraShield HardCover structure against warping, cracking, or peeling as a result of defects in material or workmanship for: 0-5 Years (100% of retail), 6-10 Years (60% of retail), 11+ Years (40% of retail) effective on the date of the original retail purchase. This warranty does NOT cover damage due to abuse, neglect, vandalism, or acts of nature.

Hardware and Seals: 2 years

Strong™ Spas warrants the integrity of the factory installed DuraShield HardCover's hardware and seals to be free from defects in materials or workmanship for a period of 2 years parts and 2 years labor, from the date of original retail purchase.

Exclusions:

This limited warranty is enforceable only by the original retail purchaser. Dealer installed accessories are specifically excluded from this limited warranty.

- All warranties are null and void if any of the following occur:
- The spa has been subject to alteration, neglect, misuse or abuse.
- Any damages caused by failure to install, maintain, and operate the spa in accordance with the recommendations contained in Strong[™] Spas' Owner's Manual.
- Any and all costs of spa's removal and replacement including but not limited to removal and transportation, damages to landscaping, house structures.
- The spa has been used in a non-residential application or an application in which it was not designed.
- HardCover damage caused by excessive heat build-up due to exposure to excessive sunlight.
- Any damages caused by improper maintenance of spa water chemistry or by any undissolved spa chemicals which may cause bleaching, erosion, or discoloration.
- Any repairs done by anyone other than an authorized Strong[™] Spas agent or anyone without the express written permission of the Strong[™] Spas warranty department.
- Do not use third-party salt-based systems in your spa! Damage caused by salt-based systems that have not been factory installed will not be covered under your warranty.

IMPORTANT: Strong™ Spas' Warranty is void if the spa is moved to any location that is not the original consumer address.
